The undersigned is directed to state that on the recommendations of the Board of Assessment for Technical and Professional Qualifications, the Government of India in the past have recognised a pass in the examinations of the Indian professional bodies/institutes, as given below, for purposes of recruitment to superior posts and services under the Central Government in the appropriate fields:-

- 1. Sections A & B of the Associate Membership Examination of the Institution of Engineers (India).
- 2. Graduateship examination of the Institute of Tele-communication Engineers (India).
- 3. Associate Membership Examination of the Indian Institute of Chemical Engineers, Calcutta.
- 4. Associate Membership Examination of the Indian Institute of Metals, Calcutta.
- 5. Part II & III of the Associate Membership Examination of the Aeronautical Society of India.
- 6. Final examination (provisionally recognized) of the Institute of Surveyors (India) in any of the following branches:-
 - (a) Land Surveying; (b) Hydrographic Surveying;
 - (b) Buildings, quantity and Valuation Surveying.

The question whether a pass in full examination or a pass partly by examination and partly by exemption of the professional bodies/ institutes be recognized for purposes of recruitment to posts and services under the Central Government was considered by the Board of Assessment for technical and professional qualifications in all its aspects. On the recommendations of the Board of Assessment, it has been decided as a matter of general policy that only a pass in full examination of professional bodies/institutions should be recognized for purposes of recruitment to posts and services under the Central Government. Passing of examinations of the professional bodies/institutions partly by examinations and partly by exemption should not be recognized for employment purposes. Accordingly a pass in full-examination (i.e. in all papers) of the above professional bodies /institutions as mentioned above should be treated as recognized by the Government of India for purposes of recruitment to superior posts and services under the Central Government.

Sir,

I am directed to state that the question whether a pass in full examination or a pass partly by examination and partly by exemption of the professional bodies/institutes be recognized for purposes of recruitment to posts and services under the Central Government was considered by the Board of Assessment for Technical and Professional Qualifications in all its aspects. On the recommendations of the Board of Assessment, it has been decided as a matter of general policy that only a pass in full examination of Professional Bodies/Institutions should be recognized for purposes of recruitment to posts and services under the Central Government. Passing of examinations of the Professional Bodies/Institutions partly by examination and partly by exemption should not be recognized for employment purposes. Accordingly a pass in full examination, i.e. in all papers, of the Professional Bodies/ Institutions as given below is treated as recognized by the Government of India for purposes of recruitment to superior posts and services under the Central Government:-

- 1. Sections A & B of the Associate Membership Examination of the Institution of Engineers (India).
- 2. Graduateship examination of the Institute of Tele-communication Engineers (India).
- 3. Associate Membership Examination of the Indian Institute of Chemical Engineers, Calcutta.
- 4. Associate Membership Examination of the Indian Institute of Metals, Calcutta.
- 5. Part II & III of the Associate Membership Examination of the Aeronautical Society of India.
- 6. Final examination (provisionally recognized) of the Institute of Surveyors (India) in any of the following branches:-
 - (a) Land Surveying; (b) Hydrographic Surveying;
 - (c) Buildings, quantity and Valuation Surveying.

The undersigned is directed to invite a reference to this Ministry's O.M. No. F.18-94/61-T.2, dated the 15th May, 1969 (copy enclosed) wherein it had been stated that the Government of India on the recommendations of the Board of Assessment for Technical and Professional Qualifications had decided that only a pass in full-examination (i.e. in all papers) of the Indian professional bodies/institutions should be treated as recognized for purposes of recruitment to superior posts and services under the Central Government.

The Board of Assessment has recently reviewed its earlier recommendations and has now recommended that the recognition to examinations of professional bodies partly by exemption and partly by examination may continue for a period of five years and the position be reviewed thereafter. The Government of India have accepted the recognition of the Board. Accordingly, a pass in the examinations of the Indian professional bodies/institutions (as mentioned in the above O.M) partly by exemption and partly by examination should be treated as recognized for purposes of recruitment to superior posts and services under the Central Government for a period of five years with immediate effect.
