His Excellency the Governor of Madras directs that the AMIE (Ind.) to be awarded after 1st November 1949 in accordance with the revised syllabus prescribed by the Institution of Engineers (India), be deemed as equivalent to the B.E. Degree of a University in the province.

His Excellency the Governor also accepts the recommendation of the Chief Engineer (Irrigation) General branch that in respect of appointments in the Madras Engineering Subordinate Service, the holders of the A.M. I. E. (Ind) qualification should be appointed only when suitable B.E.s (Civil or Mechanical) are not available.

Public Service – Tamilnadu Engineering Subordinate Service – Special Rules – Pass in Sections A and B of A.M.I.E. (India) Examination – redesignation as Junior Engineer – Amendments issued.

ORDER :

According to the first proviso to column (2) against Supervisors in Schedule II of Branch I Engineering Branch of Tamilnadu Engineering Subordinate Service a Supervisor who has passed Sections A and B of the A.M.I.E. (India) Examination should have practical experience of not less than three years after passing Sections A and B of A.M.I.E. (India) Examination for being treated as Junior Engineer. In the Central Public Works Department, a pass in Sections A and B of the A.M.I.E. (India) Examination is treated on par with the degree in Engineering and the same procedure is being followed in the States of Kerala, Haryana, Uttar Pradesh, Andhra Pradesh, Maharashtra, Mysore, Punjab and Rajasthan. The Chief Engineer has stated that it is not opportune to fall in line with the other States. Already a large number of engineering graduates are unemployed in the State and that a certain amount of restriction is necessary. He however considers that some concessions should be shown to the candidates who have passed Sections A and B of the A.M.I.E.(India) undergoing any prescribed institutional course. By the time, a supervisor passes this examination in full, he would have no doubt rendered long service in the Department. For this reason, before passing the A.M.I.E. (India) Examination is sufficient for treating one as a Junior Engineer. It has also been pointed out by the Chief Engineer that there is a very large number of supervisors who have put in along years of emergency service in the Department and that a stipulation requiring three years of regular service by them before or after passing Sections A and B of A.M.I.E. (India) Examination, will be a real hardship to them, since it will deprive them of the benefit of getting themselves redesignated as Junior Engineers after passing the above examination. The Chief Engineer has requested that the service rendered on emergency basis prior to passing Sections A and B of A.M.I.E. (India) Examination may also be allowed to be taken into consideration for the purposes of calculating previous experience and redesignating as Junior Engineer as persons of this type are better suited for the job than new recruits, by virtue of their pervious experience in the Department. The Government accepted the proposal of the Chief Engineer.

NOTIFICATION

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Government of Tamilnadu hereby makes the following amendment to the Special Rules for the Tamilnadu Engineering Subordinate Service Branch I Engineering Branch (Section 8 in Volume III of the Madras Services Mannual 1970).

Amendment

In Part II of the said Special Rules, in Schedule II to the Rules in Branch I Engineering Branch, in item I of the first proviso in column (2) against the entry "Supervisors" in column (1) thereof for the words and letter "three years after passing Section A and B" the words and letters "three years before or after passing Sections A and B" shall be substituted.

ESTABLISHMENT – Institution of Engineers (India) – Enrolment of State Public Works Department Engineers – Grant of Rs. 1000/- to meet 25% of the Membership fee – Sanctioned.

ORDER:

The President, Institution of Engineers (India), Calcutta has applied to the State Government that encouragement should be given to officers of the Government Departments to become Members of the Institution of Engineers (India) by giving them incentives like extra-pay, increment, higher scale of pay etc. The Chief Engineer, Public Works department (General) has proposed that encouragement should be given to Government Technical Officers to become members of The institution of Engineers (India), by meeting the expenditure on the membership fee, considering the technical improvements and consequent lasting benefits that would be conferred upon the State in its development activities. He recommended that a sum of Rs. 50/- per year, by way of incentive, sanctioned to such of those officers of the Department, who are already and are likely to become members of The Institution of Engineers (India).

2. The proposal of the Chief Engineer, Public Works Department (General) has been examined by the Government carefully. In the case of Institution of Engineers (India) the membership is reported to be in different categories like Studentship, Graduateship, Associate Membership and full membership with corresponding variation in rates of subscription which ranges from Rs. 30/- to about Rs. 80/- per year. In order to encourage the Engineers of the State Public Works Department whose basic pay is less than Rs. 1000/- to become associate members of the Institution of Engineers (India) the Government have decided to sanction the payment of a grant of Rs. 1000/- for current year (1971 – 72) towards sharing 25% of the Membership fees.

3. Sanction is accorded to the payment of Rs. 1000/- (One thousand only) for the year 1971 – 72, towards sharing 25% of the associate membership fee payable by this State Public Works Department Engineers, whose basic pay is less than Rs. 1000/-. The Chief Engineer, Public Works Department (General) is requested to call for application for membership to Institution of Engineers (India), from the Engineers drawing a basic pay of less than Rs. 1000/- p.m. and select in accordance with seniority the required number of members whose 25% of the membership fee could be met within the grant of Rs. 1000/-. The grant of Rs. 1000/- should be drawn and disbursed to the President of the Institution of Engineers (India) along with the 75% of the fees collected from the members. The Chief Engineers (General) is then requested to prepare,



within 3 months from the date of drawal of the amount, a detailed statement of expenditure actually incurred in meeting 25% of the membership in different categories like Studentship, Graduateship, Associate Membership and full membership in respect of the Tamil Nadu Public Works Department Engineers, who have enrolled themselves as Members of the Institution of Engineers (India) and send it to the President, Institution of Engineers (India) as well as to this Government.

4. Th expenditure should be debited to "71, Miscellaneous f. grants-in-aid, Contributions etc. – grants to Institution 24.9.1971".
